Sub:- Bar Council of Andhra Pradesh – Advocates obtained Loan of Rs. 10,000/- and Rs. 20,000/- during pandemic from the Funds of “Government Grant – Sanctioned to Bar Council of Andhra Pradesh” – Non payment of Loan amount within the stipulated time – Direction by the Special Committee to recover the Loan Amount forthwith – Reg.

With reference to the subject cited above, I am to inform you that the Advocates were granted Loan of Rs. 10,000/- & Rs. 20,000/- under the above reference from the Funds of “Government Grant – Sanctioned to Bar Council of A.P.’ during pandemic in the year 2020. Though the stipulated time for payment of Loan was completed by February, 2023, most of the Advocates have not choosen to repay the Loan Instalments.

After considering the subject, the Special Committee has directed to inform the defaulting advocates to repay the Loan Amount with Interest immediately to repatriate the recovered amount to the Government to pool-up the “CORPUS FUND.” It was further directed to informed that if any Advocate fails to repay the Loan amount, the advocate is disentitled of any Financial Assistance in future, under any Scheme, provided either by the Government or by the Bar Council.
